

Nominations Requested for the 2009 – 2010 Maine Special Education Therapist of the Year Annual Award

MADSEC requests nominations for its annual Special Education Therapist of the Year recognition program. The Executive Committee hopes that members will take advantage of this opportunity to participate in identifying and honoring one of the many outstanding individuals who enrich the lives of Maine students.

Eligibility

Active, direct involvement with special education students as an employee of a local school unit.

Method of Recognition

The recipient will receive special recognition and an engraved plaque at the MADSEC Annual Awards Dinner. Press releases will be sent to the area newspapers.

Selection Criteria

- Outstanding contributions to education and/or success as a special education therapist.
- Demonstration of an awareness of current educational developments by utilizing programs which are viable, innovative and successful.
- Demonstration of endeavor to grow professionally by attending workshops, conferences, graduate classes, and seminars.
- Involvement in the community.
- Involvement in writing grants and implementing new programs.
- Regular involvement on school committees and demonstration of leadership role.
- Involvement in staff development for regular and/or special education staff.
- Number of service years.

Deadlines

1. October 16: Nomination forms and directions distributed to Executive Committee and Regional Representatives, and all MADSEC Individual and LEA administrator members.
2. March 5: Regional nominations due at MADSEC office.
3. April 15: Awards Committee presents finalist to Representative Board.

Nomination Process

1. Any MADSEC region may nominate any special education therapist in the state.
2. Nominations are to be submitted to the MADSEC Awards Committee and the nomination package must contain:
 - a. 150-250 word provide that can serve as a basis for a press release.
 - b. Vitae of the person being nominated.
 - c. A minimum of **three** statements of support from professional colleagues, personal references, students or community members.
 - d. Permission of the nominee to pursue the processing of the nomination papers.
3. Each regional group may submit one nomination for Regular Educator of the Year to the Awards Committee.
4. The selection of Special Education Therapist of the Year will be made by the Awards Committee, approved by the Representative Board, and presented at the Annual Awards Event.
