MADSEC requests nominations for its annual award to an Advocate/Legislator/Parent of the Year recognition program. The Executive Committee hopes that members will take advantage of this opportunity to participate in identifying and honoring one of the many outstanding individuals who enrich the lives of Maine students.

Eligibility

Demonstration of a leadership role in support of students with disabilities in the State of Maine.

Method of Recognition

The recipient will receive special recognition and an engraved plaque at the MADSEC Annual Awards Dinner. Press releases will be sent to area newspapers.

Selection Criteria

- Outstanding contributions to the cause of people with disabilities.
- The nominee's activities have or will have an impact on attitudes, programs or opportunities for this population regionally or statewide.
- Number of service years.

Nomination Process

1. Nominations for this award will be made by Regional Groups of MADSEC.
2. Nominations are to be submitted to the MADSEC Awards Committee. Each regional group may submit one nomination for the Advocate/Legislator/Parent of the Year to the Awards Committee.
3. Information to the Awards Committee must include.
 - a. 150-250 word provide that can serve as a basis for a press release.
 - b. Permission of the nominee to pursue the processing of the nomination papers.
 - c. Name, address, position and description of activities leading to this nomination.
4. The selection of Advocate/Legislator/Parent of the Year will be made by the Awards Committee, approved by the Representative Board, and presented at the Annual Awards Event.

Deadlines

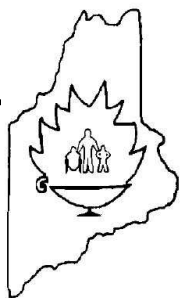
1. October 16: Nomination forms and directions distributed to Executive Committee and Regional Representatives, and all MADSEC Individual and LEA administrator members.
